**SUBJECT: TRAVEL, ACTIVITIES AND SPORTS LIABILITY WAIVER**

1. Travel Liability: I/we, the undersigned parent or guardian, authorize the above named cadet to travel by motor vehicle or other conveyances to various places for professional appointments, recreation and/or other school activities. The undersigned agrees that Massanutten Military Academy will not be held liable for any mishap or accident that may result from the use of transportation including: professional limousine, taxi, bus, watercraft, rail vehicle, air vehicle, or other vehicle. In addition, it is agreed that Massanutten Military Academy will not be held liable for any mishap or accident that may occur after departing campus. This form must be signed as a prerequisite for admission to MMA and may not be modified.

2. Athletic Program and Activities Program Release of Liability:

a. I acknowledge that the above named cadet, will participate in the athletic program and/or activities offered by Massanutten Military Academy ("the Academy"), and has my full and unrestricted permission to participate in those sports/activities shown on forms 22 and 4.

b. I am aware that athletic competition and some activities are inherently dangerous activities. I hereby agree to accept any and all risks of injury or death to my son/daughter associated with his/her participation in the athletic program and activities program offered by the Academy.

c. As lawful consideration of my son/daughter being permitted by the Academy or one of its affiliated organizations to participate in the Academy's athletic program, activities programs and use the Academy's facilities, I hereby agree that I, my heirs, distributes, guardians, legal representatives will not make a claim against, sue, attach the property of, or prosecute the Academy and/or any of its affiliated organizations or personnel/employee for injury or damage resulting from the negligence or other acts, however caused, by any employee, agent, or contractor of the Academy or its affiliates as a result of my son's/daughter's participation in the Academy's athletic/activities programs. In addition, I hereby release and discharge the Academy, its employees, and its affiliated organizations from all actions, claims, or demands, I, my heirs, assigns, distributes, guardians, legal representatives now have or may hereafter have for injury or damage resulting from the participation of my son/daughter in the Academy's athletic/activities programs.

d. I certify that my son/daughter has no known physical or mental condition that would impair his/her ability to fully participate in the Academy's athletic/activities program.

e. I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and a contract between myself and Massanutten Military Academy; and/or its affiliated organizations, and I have signed it of my own free will.

f. This agreement is valid and remains in effect for the entire period that my son/daughter remains at the Academy.
